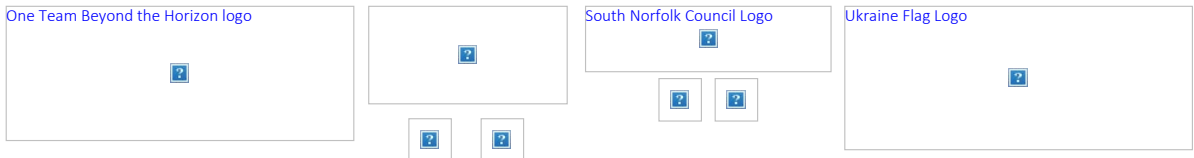
Also it has been noted that the person in question is already advertising the venue regardless of any licensing rules!!
